IRG-International Reintegration Grants (2-4 years)

A fixed amount of 25000 \in per year during the periodof reintegration and up to a maximum of 4 years (25.000 \in * 4 = 100.000 \in)

The grant is a flat rate contribution to project costs

- Salary costs of the researcher or other staff employed for the project
- Travel costs
- Consumables
- Patent costs
- Publication costs
- Equipment

Up to 3% for management activities and 10% as a contribution to overheads. The amount of Management activities and Contribution to overheads included in the fixed amount of 100.000 €. No country correction factor applied to grant.

ERG-European Reintegration Grants (2-3 years)

A fixed amount of 15.000€ during the period of reintegration and up to a maximum of 3 years (15.000€ * 3 = 45.000€)

The grant is a flat rate contribution to project costs

- Salary costs of the researcher or other staff employed for the project
- Travel costs
- Consumables
- Patent costs
- Publication costs
- Equipment

Up to 3% for management activities and 10% as a contribution to overheads. The amount of Management activities and Contribution to overheads included in the fixed amount of 45.000 €. No country correction factor applied to grant.

IRSES-International Research Staff Exchange Scheme

All partners involved in a joint exchange programme are expected to temporarily "second" their staff and thus continue paying their salary during the stay abroad

- For each member of staff from an EU MS or AC staying in an eligible Third Country partner organisation, the Community will pay a subsistence allowance of 1800€ per month The subsistence allowance is paid as a fixed contribution expected to cover the costs for the staff exchange, including travel costs and other related costs.
- Partner organisations from Eligible Third countries are supposed to cover themselves the costs for their "outgoing" staff.





FINANCIAL REPORTING

The subsistence allowance of 1800€ per month and exchanged member of staff is paid as a fixed contribution. When reporting to the Commission, beneficiaries will not have to provide evidence of actual costs (cost statements for air travel tickets, evidence how much each researcher has received individually, etc). Reporting will be limited to the accomplished results, which includes number of person-months exchanged and scientific results achieved, under consideration of the objectives set out in the Work Programme.

IAPP-Industry – Academia Partnerships and Pathways

The financial support for IAPP is calculated on the basis of eligible activities and takes the form of grants covering up to 100% of the budget.

Mobility allowances

This is a monthly payment of a fixed amount to cover expenses of the researcher related to his/her mobility (relocation, family expenses)

- €800/month: Researcher with family obligations (mariage or relationship with equivalent status to a marriage recognized by the national legislation of the country of the host organisation or the nationality of the researcher, and/or children).
- €500/month: Researcher without family obligations

Travel allowance (yearly)

This refers to an allowance upon taking up employment and yearly thereafter. The allowance is a fixed amount based upon the direct distance between the location of origin of the researcher and the location of the host institution. Each IAPP researcher is entitled to at least one travel allowance. A fellowship of between 13-24 months is entitled to 2 travel allowances.

Career exploratory allowance (single payment)

2. Eligible expenses for the activities carried out by the Host organisations

Contribution to the research/transfer of knowledge programme expenses

800€ per researcher per month that goes to the hostorganization for the execution of the project

- Publication of the vacant positions
- Internal training actions
- Participation of eligible researchers in research and transfer of Knowledge activities (research costs, participation in meetings and conference attendance)
- Contribution to the expenses related to the co-ordination between participants (partnership meetings, secondment of staff)

Contribution to the organisation of international conferences, workshops and events

This contribution is managed by the host institution for the organisation.

Fixed amount contribution of 300€ per researcher-day for researchers from outside the partnership, for the duration of the event

- Invitation of Keynote speakers
- Publication
- Rental of premises
- Web casting
- Participation fees of eligible researchers from outside the partnership

Management activities

Maximum of 3% of the total Community contribution

- Towards the salary of a person dedicated to assist with the management of the project
- Contract with an external independent auditor certification (in case of public or international organisations this certification may be provided by a competent public official.

Contribution to overheads

Flat rate payment of 10% of the direct costs **EXCLUDING** costs for subcontracting.

Small Equipment (for SMEs only)

Up to maximum of 10% of the total contribution to the SME participant





ITN-Initial Training Networks

The financial support for ITN is calculated on the basis of eligible activities and takes the form of grants covering up to 100% of the budget.

Career exploratory allowance (single payment)

This allowance of a single payment of 2000€/fellow, only for stays of at least one year, is intended to enable each researcher to help develop their career

Is only paid to early-stage and experienced researchers recruited for initial training

Contribution to the participation expenses of eligible researchers

This contribution is managed by the hosting organisation for expenses related to the participation of the researchers in research and training activities

- Contribution to research-related costs

It consists of a fixed amount

- 600€ per researcher-month recruited for initial training: for laboratory based research projects
- 300€ per researcher-month for initial training: fornon-laboratory based research projects

A contribution of a fixed amount of 600€ per researcher month. This contribution rather goes a) to the host organisation to contribute to the overall expenses related to the execution of the training project

Management activities
